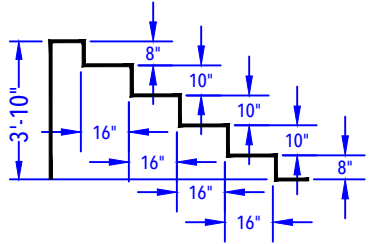

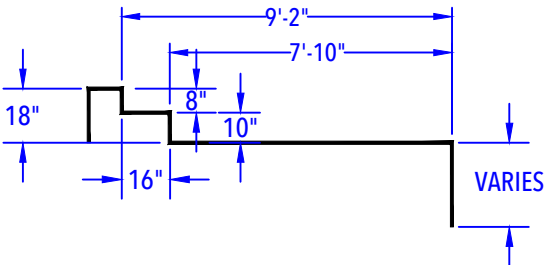

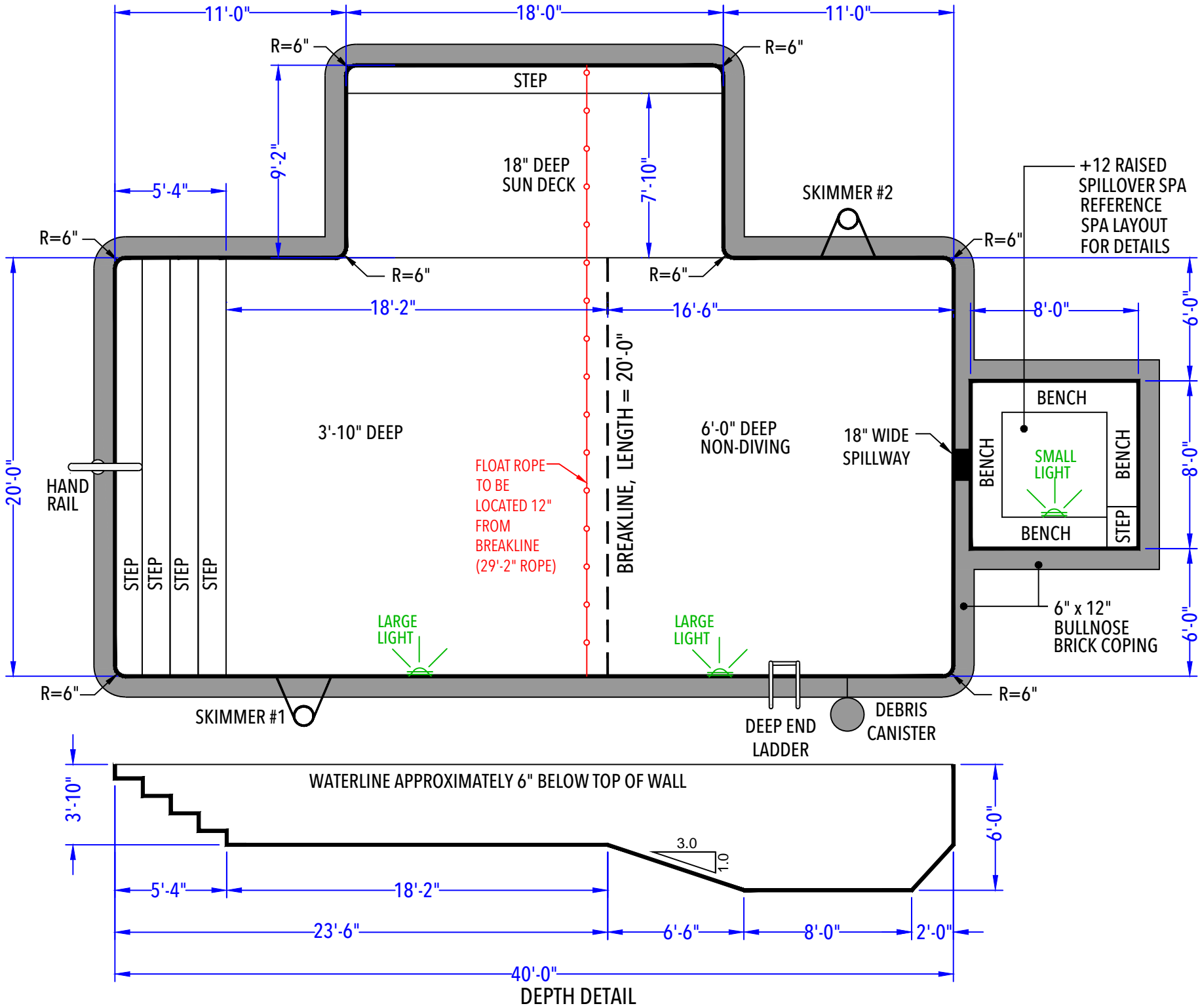
ENTRY STEP DETAIL

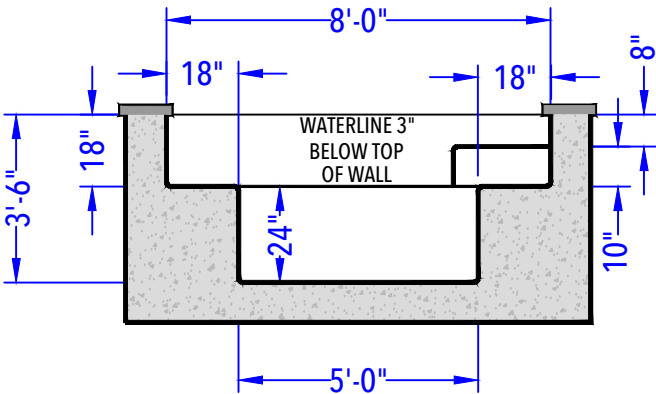
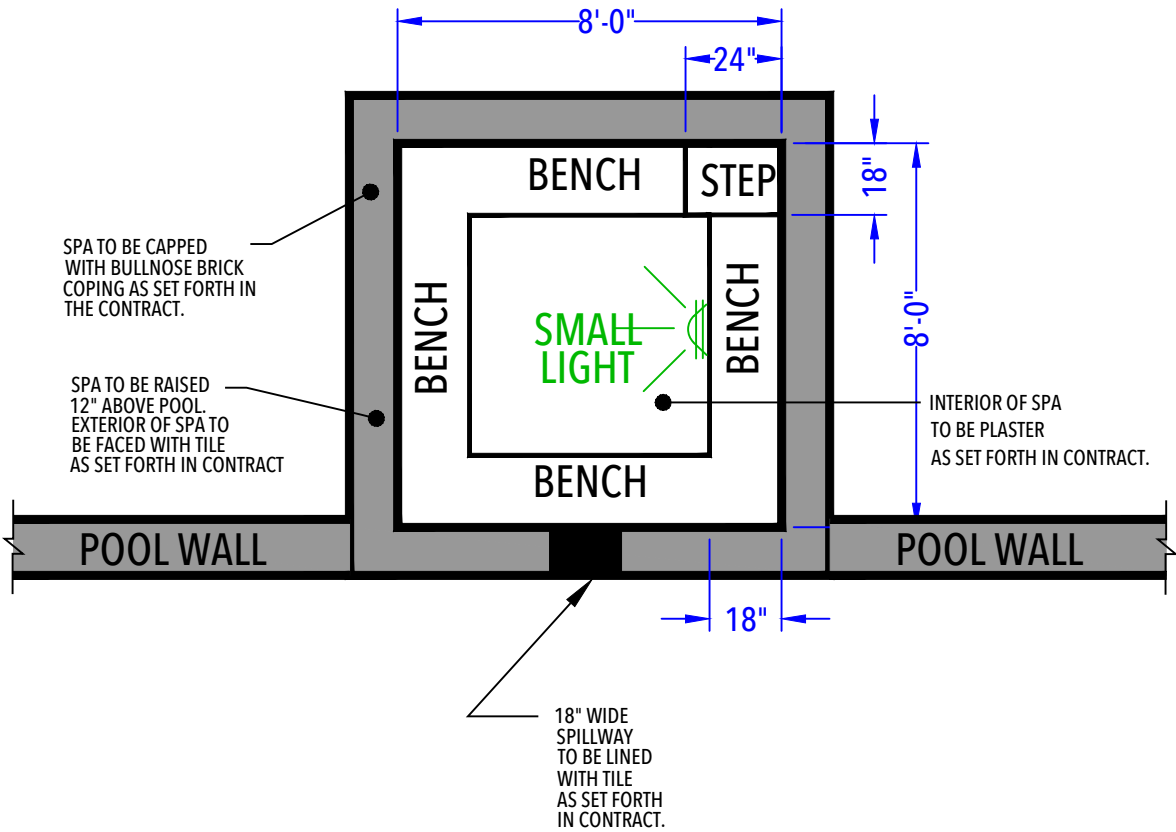
