Buyer acknowledges that any changes or deviations to these plans as requested or done so by Buyer may be subject to approval by the Township or other governing authority and Buyer agrees to take full and complete responsibility for any changes that are made. Furthermore, any changes to the Pool Layout Plan as requested by the Buyer are subject to price changes and delays to the start date or construction durations, as applicable. Seasonal World is not responsible for any topographical errors and/or omissions that may occur in the preparing of the Pool Layout Plan. In the event that a product or service is incorrectly shown or listed in Pool Layout Plan and it has not been purchased on the Contract or via Contract Addendum by Buyer, this does not entitle the Buyer to receive said product or service. Product or service must be purchased and paid for in order for Seasonal World to provide it to the Buyer unless otherwise specified in writing.
